2. Approval of the 20 June 2024 Minutes of the 2024 Bond Hearing, 2024 Budget Amendments Hearing, and 2025 Proposed Budget Hearing:

Trustee Turner made a motion to approve the 20 June 2024 Minutes for the Local Building Authority of the Salt Lake City Mosquito Abatement District 2024 Bond Hearing, 2024 Budget Amendments Hearing, and 2025 Proposed Budget Hearing.
